



## VERIFICATION STATEMENT GREENHOUSE GAS EMISSIONS

Bureau Veritas North America, Inc. (BVNA) was engaged to conduct an independent verification of the greenhouse gas (GHG) emissions reported by Regeneron Pharmaceutical, Inc. (Regeneron) for the period stated below. This Verification Statement applies to the related information included within the scope of work described below.

The determination of the GHG emissions is the sole responsibility of Regeneron. BVNA's sole responsibility was to provide independent verification on the accuracy of the GHG emissions reported, and on the underlying systems and processes used to collect, analyze and review the information.

### **Boundaries of the reporting company GHG emissions covered by the verification:**

- Operational Control
- Regeneron's activities in Rensselaer, New York; Tarrytown, New York; Sleepy Hollow, New York; Basking Ridge, New Jersey; and Raheen, Ireland locations (Scope 1)
- Regeneron's facilities located in Rensselaer, New York; Tarrytown, New York; Sleepy Hollow, New York; Basking Ridge, New Jersey; Uxbridge, United Kingdom; Raheen, Ireland; and Dublin, Ireland locations (Scope 2)

### **Emissions data verified:**

- **Scope 1:** 58,200 metric tons of CO<sub>2</sub> equivalent
- **Scope 2:** (Location-Based) 41,400 metric tons of CO<sub>2</sub> equivalent  
(Market-Based) 27,800 metric tons of CO<sub>2</sub> equivalent

### **Period covered by GHG emissions verification:**

- January 1, 2018 to December 31, 2018

### **GHG Reporting Protocol against which verification was conducted:**

- World Resources Institute (WRI)/World Business Council for Sustainable Development (WBCSD) Greenhouse Gas Protocol Corporate Accounting and Reporting Standard

- Audit of sample of data used by Regeneron to determine GHG emissions.

**Assurance Opinion:**

Based on the process and procedures conducted, there is no evidence that the GHG emissions assertion shown above:

- is not a fair representation of the GHG emissions data and information; and
- has not been prepared in accordance with the GHG Protocol standard listed above

It is our opinion that Regeneron has established appropriate systems for the collection, aggregation and analysis of quantitative data for determination of these GHG emissions for the stated period and boundaries.
